Dear Club Secretary,

On behalf of the Pennsylvania State Rabbit Breeders Association (PaSRBA), I am writing to ask if your specialty club is interested in having a specialty show at our annual convention, February 6-7, 2010. The convention will be located at the Lebanon Expo Center in Lebanon, PA.

The PaSRBA convention is the largest rabbit show in the state of Pennsylvania. The 2009 convention attracted exhibitors from over 16 states in the Mid-Atlantic, East Coast, and Mid-West and is now one of the largest shows in the country. Over 12,000 animals were judged over the weekend between the PaSRBA and specialty club shows.

The cost for this specialty show will be as follows:

- Non-PaSRBA Affiliated clubs: \$2.00 per animal judged.
- PaSRBA Affiliated clubs: \$1.50 per animal judged.
- **All shows must be PASRBA sanctioned \$10.00. All PaSRBA sanction requests (complete with ARBA sanction numbers and fees) should be sent to Peg Hailey.**
- The specialty club must do ALL paperwork, provide ALL awards, and obtain appropriate sanctions from ARBA and national specialty clubs.
- All clubs wishing to host a specialty need to submit the required paperwork via e-mail or postal mail- All requests must be put in writing, no verbal requests will be accepted!
- All requests to host a specialty show must be submitted by **August 22, 2009.** Requests made after this time will not be honored. After this date, PaSRBA will sponsor selected specialty shows for breeds that have no specialty club show requests.
- Payment will be required at the end of the specialty show. If payment is not received by the end of PaSRBA Convention a late fee of 25% will be assessed.

PaSRBA will provide the specialty club with the following for the day of their show:

- A judge, show table and holding pens.
- Information in the show catalog about your specialty show.
- A list of judges to choose from (we will try our best to honor your top requests).
- A shared table space and two chairs only to take entries and distribute awards will be placed in a location at the Superintendent's discretion (probably West Hall).
- In lieu of shared table space, clubs may purchase a booth space if desired for \$50(affiliated clubs) or \$75(non-affiliated clubs). An extra table will be \$20 and an extra chair will be \$5. Booth location will be determined by PaSRBA Superintendent based on space availability. Payment of booth fees must be received with the specialty show application.
- **SPECIALTY CLUBS MAY NOT SET UP THEIR OWN TABLES WITHOUT THE APPROVAL OF THE SUPERINTENDENT.**

I look forward to hearing from you and working with you and your specialty show. Please return the enclosed form by **August 22, 2009 if you wish to hold a specialty show.**
